## Summary

- The Northern Ireland Committee for Health undertook a consultation on the Severe Fetal Impairment Abortion (Amendment) Bill.
- A total of 9,125 individuals and organisations made written submissions to the consultation.
  - 9,084 (99.55%) submissions supported the Bill.
  - 36 (0.39%) submissions did not support the Bill.
  - 5 (0.05%) submissions neither supported or opposed the Bill.

## Methodology

- Don't Screen Us Out undertook an analysis of all published written submissions made to the Northern Ireland Committee for Health consultation on the Severe Fetal Impairment Abortion (Amendment) Bill.
- We reviewed all published submissions and coded the content of the submissions into three categories:
  - Supportive of Severe Fetal Impairment Abortion (Amendment) Bill
  - Opposed to Severe Fetal Impairment Abortion (Amendment) Bill
  - Neither supportive or opposed to the Severe Fetal Impairment Abortion (Amendment) Bill
- Published submissions were sourced from the [Written submissions from individuals](#) and [Written submissions received from organisations](#) pages on the Northern Ireland Assembly website.
- A total of 9,125 individuals and organisations made written submissions to the consultation.
  - 9,084 (99.55%) submissions supported the Bill.
  - 36 (0.39%) submissions did not support the Bill.
  - 5 (0.05%) submissions neither supported or opposed the Bill.
